INVITATION FOR TENDER

1-) SUBJECT:

S.S. Tariş Üzüm Tarım Satış Kooperatifleri Birliği intend to import by tender procedure 300 tons (with the option of $\pm 25\%$). POTASSIUM CARBONATE under the following terms and conditions.

The rate of any increase or decrease in the quantity will be at Tariş's option and the net amount of purchase will be fixed while the order is placed.

2-) TECHNICAL AND QUALITY SPECIFICATIONS:

MOISTURE	: Max. 2 %
INSOLUBLE SUBSTANCES IN WATER	: Max.0.02%

The participant companies must guarantee that specification values of the potassium carbonate offered will be suitable with the above stated values.

Potassium Carbonate with content of the lead below 5 ppm may be a reason for preference.

PACKING: In polyethylene bags of 25 Kg.net (There will be no polypropylene or craft bag secondarily wrapped around the polyethylene bag) on the shrink-wrapped pallets.

LOT NO, PRODUCER COMPANY NAME, PRODUCTION and BBE dates should be written on packages. Also, this information should be determined on Health Certificate.

Delivery must be certainly made with container. **(Pallet weight shall be 1.000 Kgs. at container loading. Empty packaging must be included for 1% of the packaging amount on each pallet)**

A POTASSIUM CARBONATE OFFERS, WHICH ARE RUSSIAN AND CHINA ORIGINATED SHALL NOT BE TAKEN INTO CONSIDERATION. GOODS WHICH ARE NOT SUITABLE WITH THE ABOVE SPECS WILL NOT CERTAINLY BE SHIPPED AND WILL NOT BE ACCEPTED BY OUR UNION.

3-) TERMS OF THE SHIPMENT:

- Companies will indicate and undertake the shipment and the estimated arrival dates to ALİAĞA clearly in their offers. The ideal anticipated arrival date to Aliğa of the goods will be **second half of June to latest first week of July** for our Union.
- The Companies will consider this point in their offers. The free time of the containers must be at **least 10 days.**
- Partial shipment and transshipment may be allowed depending on the shipment port.
- Port of loading and the country of origin of the goods must be indicated in the offers. The Vessel assigned for the transport of the mentioned goods will have **maximum 15 years of age, will have LLOYDS Certificate and with a Class.**

4-) TERMS OF THE PAYMENT AND THE ORDER:

- a- Payment shall be affected on cash against documents basis after the presentation of the full set of original documents to our bank, upon arrival of the vessel to Aliğa.
- b- Full set of original documents to be presented to our bank latest five days prior to the vessel's arrival to Aliğa. All banking charges are for the Seller's account.
- c- The payment of **% 100** of the invoice value will be affected against the presentation of the documents upon arrival of the vessel to Aliğa Port.
- d- Companies will give sample of Health Certificate which is approved by the officially authorized office issued for potassium Carbonate together with **their offer**.

5-) WAYS OF OFFERING:

- a- The price quotations must be given on **CFR/ALİAĞA** delivery basis.
- b- Original technical specifications of the offered goods will contain whole parameters stated on Invitation for Tender and must be present together with the offer duly signed and stamped onto headed paper of the producer company. Technical specifications, which will be present together with the offer, will be accepted as undertakings of the Firms. If the Firms do not present technical specifications together with the offer, in this case, Firms offer will not be taken into consideration.
- c- Offers prepared in compliance with the terms and conditions of this tender must be sent to our address (given below) **either by mail, fax or post delivery, not later than 25.03.2026 till 15:00 pm (Turkish time). The tender will be closed bidding and declared prices on the offers of the participant companies will be accepted as a final price on the mentioned tender time.**
- d- Offers received after the above-mentioned date will not be taken into consideration.
- e- Offers must be valid until **31.03.2026 till 18:00 o'clock (Turkish time)**
- f- If the offer is submitted by a representative of the Seller in Turkey, a letter of authorization must be presented together with the offer.
- g- It is imperative to indicate clearly in the offers that all terms and conditions of these tender specifications are fully accepted.

6-) PERFORMANCE BOND:

Seller shall obtain a ten percent (**% 10**) Performance Bond of the amount of the order to the favor of **"S.S. TARİŞ ÜZÜM TARIM SATIŞ KOOPERATİFLERİ BİRLİĞİ"** within latest 10 days following the awarding contract. Performance bond will be issued by a first-class Turkish Bank to the name of **S.S. TARİŞ ÜZÜM TARIM SATIŞ KOOPERATİFLERİ BİRLİĞİ** against the counter-guarantee issued from a First Class International Bank. Performance Bond will guarantee the shipments and arrival date of the goods to Aliğa and all undertakings of the Seller with the related tender. **The validity of the %10 Performance Bond must be until the end of October 2025.** The Performance Bond will be returned to Seller after the goods are imported and after the seller have fulfilled his undertakings. If the Seller has fulfilled the undertakings in his offer after the order is placed, in this condition Performance Bond of the Seller will be turned into cash and it shall be considered as income.

12-) THOSE WHO SHALL NOT PARTICIPATE IN TENDER:

- a- Although awarded by the tender, those who don't complete the contract as per procedures and cease from their undertakings after completion of the contract. Those who don't do their undertakings except force majeure.
- b- Those, showing concrete negligence and negativity, acting contrary to the contract conditions and putting union and the Cooperatives in difficult positions,
- c- Those having legal disputes with TARIŞ
- d- Those whom, distrusting information is obtained from public conscience, press and similar organs for intruding the tender.
- e- Those prohibited of entering into state tenders indefinitely or for a certain period.
- f- The president and the members of Tariş Union and Cooperatives Board of Directors and inspection Committee.
- g- The personnel and their spouses working in Tariş Cooperatives and Unions and related offices and factories.
- h- Officials in charge of preparing, executing, concluding and inspecting the tender operations and officials an every rank of related units advising technical opinions.
- i- Corporate bodies owned by the capital majority of real people whose positions suitable to paragraphs (a),(b),(c),(d),(e)
- j- Partners of corporate bodies or corporate bodies having majority of these shares whose positions are suitable to paragraphs (a),(b),(c),(d),(e)
- k- Spouses of individuals stated in paragraphs (f) and (h) and to second degree, including the second degree, blood relatives formed due to marriage (mother, father, grandmother, grandfather, child, grandchild, brothers and sisters, spouses mother, father, grand mother, grandfather, brothers and sisters)
- l- Individual or Capital Companies owned by legal people stated in (f),(g) and (h) and the company representatives.
- m- Those who are in the habit of not presenting serious offer although TARIŞ has given proficiency certificate before.
- n- Those whose insufficiencies of intentional conditions are determined in tenders previously done by TARIŞ.

Directly or indirectly can not enter, their offers will not be evaluated and therefore they cannot demand any right, expenditure and compensation. The registration of performance bonds of participants as income, if the contract is made, the cancellation of the Contract, registration of Performance Bond as income is at Union's option.

13-) This tender of Our Union is not subject to **Public Tender Law no 4734** and is entirely at liberty to carry on or to cancel this tender or to carry it on partially or to conclude business with whoever it wishes to choose. The participants in the tender cannot claim any right due to participating in the tender.

14-) The address, which will be stated in the offer shall be accepted as legal address and all sort of declaration which shall be made to this address will be acceptable.

15-) Tender Winning Company cannot transfer the work to any other Firm or company without the written consent of Tariş.

16-) The Tender Commission, incase there are no participants or the offered amounts in the tender are not found suitable by the Commission, can leave the tender to another day and amend the tender method at the same time can cancel the tender also.

17-) The disputes, which may occur and the Bailiff Departments. Turkish legislation topics will be accepted.

18-) Evaluating alternative offers is at our Union's option.

19-) A Potassium Carbonate offers, which are Russian and China originated shall not be taken into consideration.
